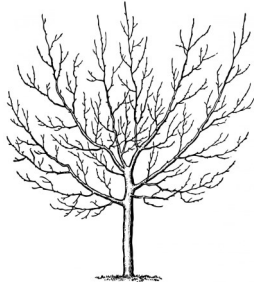

## WINTER WATERING ...

As we continue to experience warm, dry temperatures, winter watering in Colorado is necessary. Keeping the new trees alive is imperative and required to continue with the Tree Share Program offered through the Town. Winter watering is recommended to prevent root damage of the lawns and perennials. Be sure to only water when the soil and air temperatures are above 40°F. Water in the morning hours so the water has enough time to saturate before the evening hours when the temperatures drop.
